

### COVID-19 Reported Case Update

**Hillsborough Township is notifying residents of a second positive case of COVID-19 (Coronavirus) in the Township.** The Hillsborough Township resident is currently in isolation. The Hillsborough Township Health Department is monitoring the resident and is working with the state to identify any potential contacts for follow-up. A representative from the Hillsborough Health Department will reach out to you within 24-48 hours if you were in close contact with this resident. ### Message from Mayor Tomson Regarding March 24th Township Committee Meeting

We are all operating under unique circumstances attributable to the COVID-19 virus. The next meeting of the Township Committee is scheduled for Tuesday, March 24, 2020, at 7:30 pm. We are working on providing residents with the opportunity to participate in this meeting remotely. Residents should access the Township website prior to the scheduled meeting to ascertain how they can participate remotely. A number of residents have expressed interest in commenting on Ordinance 2020-08 which amends Chapter 188 "Land Use and Development", Article V "Districts and Standards", Section 188-98 RA, RS, R, R1, R2, CR, AH, RCA, PD Residential Districts, by adding R8A Zone to apply to Block 182, Lots 9, 11.01 and 46.01 and Block 183, Lot 38.02. At the March 24, 2020 meeting, I intend to ask my fellow committee members to delay a final vote on the Ordinance and continue the public hearing to the April 28, 2020 Township Committee meeting to provide residents additional opportunity to comment on this Ordinance. Those residents may also participate and comment remotely at the March 24, 2020 meeting.

### Township Updates, Closures and Cancellations

- The Municipal Building will be closed to the public. Please refer to our Township [website](#) for self-services functions like on-line payments, forms and contact phone numbers for departments.
- All Department of Public Works Programs are suspended until May and at that time the programs will be reevaluated. This includes ALL Clean Communities Events, Annual Cleanup Events, Sr. Curbside Pickup and Grass and Leaf drop off. If your date is cancelled we will withdraw you from the event and you will be able to select a different date when the system becomes active. Community Pass is currently NOT available to register for programs. Please check our [website](#) for updates when they become available. The Public Works yard is also closed to the public. - **Hillsborough Township Fire District / Hillsborough Police Department Incident Response Temporary New Guidelines** - these are the steps Hillsborough Township Fire District / Hillsborough Police Department are taking. Responses to investigations or activated alarms within the interior of a structure and to automobile accidents with patient contact, the first-responders will be dressed in full personal protective equipment along with masks, which may include self-contained breathing apparatus and medical gloves. A crew of two will enter the interior of the structure while other members will be positioned outside or will remain inside the apparatus unless needed. If you witness this type of response procedure, there is no need for alarm or panic, these are just the additional safety measures being taken during this worldwide health emergency to keep everyone as safe as possible.

**UPDATE:** ShopRite of Hillsborough will offer designated grocery shopping time for senior citizens, age 60 or over, or anyone in the high-risk category. As of Friday, March 20th, ShopRite of Hillsborough will be open from 7 am to 8 am for those in the high-risk category only. All store departments will be open, except the Pharmacy Department, which will be open at their normal time of 8 am. [COMCAST Announces Comprehensive COVID-19 Response to Help Keep Americans Connected to the Internet](#)

**UPDATE:** Comcast has announced an expansion of the availability of their Internet Essentials program. Internet Essentials is normally available to all qualified low-income households in Comcast's service area for \$9.95/month. Beginning Monday, new families who connect to Internet Essentials will receive 60 days of broadband service for free. Additionally, over the next few days, Internet Essentials speeds will be increased from 15/2 MBPS to 25/3 for all new and existing customers, and will become the speed of the service going forward. More information about the expansion can be found on the company's [website](#).
