

Updates, Closures and Cancellations

The Building Department is beginning a temporary system of electronic documentation in lieu of required interior inspections of Occupied Buildings.

If you are the owner or contractor of a project that needs an inspection of the interior of an Occupied Building, please make your request for each inspection as follows:

1. First, send an email request for photo documentation in lieu of required field inspections, with your Permit Number, to the appropriate Subcode Official, (Fire, Electrical, Plumbing/Mechanical, or Building).
2. The Subcode Official will respond with a specific list of areas they will need photo evidence of, specific to your project and inspection type.
3. The photos emailed to the Subcode Official must include a scanned copy or photo of a completed, "[Affidavit in Lieu of Required Inspection Due to COVID-19](#)" with an original signature applied to it. Each photo emailed should be labeled with a very brief description of the details provided.

When this submittal is received and reviewed by the Subcode Official or Inspector, they will schedule a time to call you to discuss your results.
